## NATIONAL DEPARTMENT OF HEALTH POLICY GUIDANCE TO VACCINATION SITES

## Circular 01/4 June 2021

Note: these guidelines apply to both public and private health vaccination sites, but not to workplace sites.

- 1. Eligibility for Vaccination
- a. South Africa is currently vaccinating persons aged 60 years and above and healthcare workers. No other groups should be vaccinated at present, unless stipulated by the NDOH.
- 2. Registration on the Electronic Vaccination Data System (EVDS) for general population aged 60 and above
- a. In order to participate in the national vaccination rollout, all eligible individuals must be registered on the Electronic Vaccination Data System (EVDS).
- b. Currently only those aged 60 and above are eligible to register on the EVDS.
- c. Once registered, the individual will receive an SMS confirming their registration.
- d. A subsequent SMS will be sent notifying the registrant of the details of their scheduled vaccination appointment.
- e. All sites are requested to provide vaccinees at least 3 days notice of their appointments, if possible.
- f. The National Department of Health will announce when the EVDS system will open for the registration for other age groups in due course.
- 3. Healthcare Worker Registration

- a. The EVDS is now closed to new registrations by Healthcare Workers.
- b. All Healthcare Professionals i.e. registered with a professional body and who are already registered on the EVDS system will be transferred to the [www.v4hcw.co.za] system which will manage their vaccination scheduling. c. All unregistered Healthcare Professionals are to register on [www.v4hcw.co.za].
- d. Details on how other Healthcare workers can register will be announced shortly.
- 4. Walk-in Policy Guidance
- a. While walk-ins are discouraged, we recognize that for practical reasons some sites across both the public and private sectors are currently accepting unscheduled "walk-ins" over the age of 60.
- b. Vaccination site managers are granted discretion to accept walk-ins over 60 subject to the following guidance:
- i. All individuals with scheduled appointments must be given priority over unscheduled "walk-ins".
- ii. Site managers must ensure they have sufficient stock to vaccinate those scheduled for vaccination at their site before they open for walk-ins.
- iii. If a walk-in is not yet registered on the EVDS, they will need to be registered on the EVDS at the site before they can be vaccinated.
- iv. Public sector sites may accept walk-ins over 60 at their own discretion subject to 4(b)(i), 4(b)(ii) and 4(b)(iii)
- v. Private sector sites may accept insured walk-ins over 60 at their own discretion subject to 4(b)(i), 4(b)(ii) and 4(b)(iii)
- vi. Private sector sites dealing with uninsured walk-ins should note that:

1. The NDOH will not pay for uninsured walk-ins to private sites. These individuals are to be referred to public sites.

- 2. The exception is that private sector sites are authorised to vaccinate uninsured walk-ins aged over 80 years, and to reclaim the cost from the state.
- 3. This cohort is not expected to exceed 5% of the private sector site's vaccine allocation.
- c. Proof of age includes an ID, a passport or driver's license.
- d. Walk-ins are not guaranteed to receive a vaccine on the day of registration or at all, and may be required to return on another day, depending on site capacity.

- e. Where practical, vaccine sites are advised to set up separate and clearly marked queues for walk-ins, to ensure that individuals with appointments scheduled by the EVDS are prioritized.
- 5. Cost and Reimbursement Guidance
- a. All vaccines are free to the individual at the point of administration, both for those who are uninsured and insured.
- b. No vaccination site may charge any fee to the individual presenting themselves for vaccination.
- c. The vaccine cost and the vaccine administration cost for uninsured vaccinees will be covered by the state and for insured vaccinees by their medical schemes.
- d. Wherever possible uninsured individuals will be directed to public sites and insured individuals to private sector sites.
- e. Where an uninsured individual is scheduled by the EVDS to a private vaccination site, the state will cover the vaccine cost and vaccine administration cost.
- f. Where an insured individual is scheduled by the EVDS, or is a walk-in to a public vaccination site, the state will recover the vaccine cost and vaccine administration cost from the insured individual's medical scheme.
- g. The state will only reimburse private sites for the vaccine cost and vaccine administration costs for uninsured walk-ins over the age of 80, up to a limit of 5% of the site's vaccine allocation.
- h. The reimbursement mechanism for this will be in line with the provisions of the Sales and Distribution agreement.
